Re: Algola Seaweed Cream Our Reference: C259 259-2013

We have reviewed your draft label text shown at Attachment 1 for compliance with the requirements for 'cosmetics' in Australia. To meet the requirements for cosmetics a product must:

- Meet the definition of cosmetic in the Industrial Chemicals Act 2019;
- Not be scheduled in schedules 2, 3, 4 or 8 of the Standard for the Uniform Scheduling of Medicines and Poisons (SUSMP);
- Include only ingredients that are listed on the AICIS Inventory database or are exempt from listing on the database;
- Not include any prohibited chemicals and meet any conditions for use of restricted chemicals:
- Meet any applicable conditions of a cosmetics standard that applies to the product (if any);
- Meet the labelling requirements of the Trade Practices (Consumer Product Information Standards)(Cosmetics)Regulations 1991; and
- Be marketed as a cosmetic.

To be a cosmetic, the product must meet the definition of cosmetic in Australia under section 9 of the Industrial Chemicals Act 2019, namely:

cosmetic means:

- (a) a substance or preparation intended for placement in contact with any external part of the human body, including:
- (i) the mucous membranes of the oral cavity; and
- (ii) the teeth;

with a view to:

- (iii) altering the odours of the body; or
- (iv) changing its appearance; or
- (v) cleansing it; or
- (vi) maintaining it in good condition; or
- (vii) perfuming it; or
- (viii) protecting it; or



(b) a substance or preparation prescribed by rules made for the purposes of this paragraph; but does not include:

- (c) a therapeutic good within the meaning of the Therapeutic Goods Act 1989; or
- (d) a substance or preparation prescribed by rules made for the purposes of this paragraph.

The ingredients and CAS numbers have been provided by the manufacturer as shown in Attachment 2. We have assessed whether the ingredients and CAS numbers shown are included in the AICIS Inventory and the SUSMP and our findings are shown in Attachment 2.

The ingredient quantities have not been provided, so we are unable to verify the manufacturer's statement that they are listed in the correct order on the product label (Attachment 1).

The manufacturer has stated that the iodine content of the product and the quantities of bergamot oil and lime oil included in it are below the schedule cut off levels, so the product is unscheduled and no additional label warnings are required.

In our view, the product will meet the requirements for a cosmetic provided that:

- the product is labelled with the text as shown in Attachment 1, and
- the formulation only includes ingredients with the CAS numbers shown in Attachment 2, in quantities that mean that the product is unscheduled and
- the product meets the requirements listed above.

This product can be marketed without specific approval from the Therapeutic Goods Administration or AICIS as long as it continues to comply with the above requirements.

In providing this advice we note that there are subjective elements to decisions on whether a claim is 'cosmetic' or not. However, if challenged, we believe you can probably support the position that these products are appropriately regulated as 'cosmetics'.
